



PEC's 2018 Holiday Lights Photo Submission Contest Terms and Conditions

Introduction

The PEC Holiday Lights Photo Submission Contest is sponsored by Pedernales Electric Cooperative (PEC). This contest is governed by these official rules ("Official Rules"). By participating in the contest, each entrant agrees to abide by these Official Rules, including all eligibility requirements, and understands that the results of the contest, as determined by PEC and its agents, are final in all respects. The contest is subject to all federal, state and local laws and regulations and is void where prohibited by law. This promotion is in no way sponsored, endorsed or administered by, or associated with, Facebook. Any questions, comments or complaints regarding the promotion will be directed to PEC, not Facebook.

Eligibility

The PEC Holiday Lights Photo Submission Contest is open to U.S. residents where not prohibited by law, who are eighteen (18) years of age or older at the time of entry. PEC reserves the right to verify the eligibility of each entrant.

Contest Period

The contest begins Nov. 23, 6 p.m. CST and ends January 1, 2019, noon CST. ("Contest Period"). All entries (submissions) must be received on or before the time stated during the Contest Period. PEC reserves the right to extend or shorten the contest at its sole discretion.

How to Enter

PEC Holiday Lights Photo Submission Contest participants can enter through either of the following methods: (1) Facebook: posting a photo to PEC's official Facebook page (facebook.com/pedernalescoop), the Facebook Event page or to a participant's Facebook page with the #PECHolidayLights hashtag. (2) Instagram: post a photo with the #PECHolidayLights hashtag. (3) Twitter: post a photo with the #PECHolidayLights hashtag. Details for submission requirements will be available on the PEC Facebook page and the PEC website on or before the contest's Nov. 23, 6 p.m. CST start time. Participants will receive one (1) entry into the contest for each photo submission. You may enter as many times as you wish. The contest ends Jan. 1, 2019, noon CST.

Winner Selection

One winner will be selected randomly from each platform (Facebook, Instagram and Twitter) based on the photo submissions received. The winners will be announced on or about Jan. 8, 2019. Announcement and instructions for prizes will be made by contacting the respective

social media account associated with each photo submission. Each entrant is responsible for monitoring his/her social accounts for prize notification and receipt or other communications related to the Contest. If a potential prize winner cannot be reached by the contest administrator within thirty (30) days, the potential prize winner shall forfeit the prize. Upon the request of PEC, the potential winner may be required to return an Affidavit of Eligibility, Release and Prize Acceptance Form and IRS W-9 form. If a potential winner fails to comply with these official rules, that potential winner will be disqualified. Prizes may not be awarded if an insufficient number of eligible entries are received.
